Keynote speakers

- Professor Simon Dixon holds the Sir Bernard Pares chair of Russian History at the School of Slavonic and East European Studies, University College London. He has written very widely on the history of modern Russia and his publications include *The Modernisation of Russia, 1676-1825* (1999) and *Catherine the Great* (2009). Professor Dixon is a member of the Council of the Royal Historical Society.
- Luke Harding is an award-winning foreign correspondent with *The Guardian*. He has reported from Delhi, Berlin and Moscow and has covered wars in Afghanistan, Iraq, and Libya. His book *Mafia State: How one reporter became an enemy of the brutal new Russia*, was published by Guardian Books in 2011. He is currently based at *The Guardian's* office in London.
- Professor Adele Lindenmeyr is Professor of History and Dean of Graduate Studies in the College of Liberal Arts and Sciences at Villanova University, Pennsylvania, USA. Her books include Poverty is Not a Vice: Charity, Society and the State in Imperial Russia (1996), which was awarded the Heldt Prize for the best book published by a woman in Slavic Studies. Professor Lindenmeyr was honoured with the Outstanding Achievement Award by the Association for Women in Slavic Studies in 2003.
- Professor Sabrina P. Ramet is Professor of Political Science at the Norwegian University of Science and Technology in Trondheim. Her expertise lies in the area of central and east European politics and culture and she has published *The Three Yugoslavias: State-building and Legitimation, 1918—2004* (2006) and *Civic and Uncivic Values in Macedonia* (2013). Professor Ramet is a member of the Royal Norwegian Society of Sciences & Letters.
- Professor Richard Sakwa is Professor of Russian and East European Politics at the University of Kent. A leading expert on the politics of contemporary Russia, his books include The Crisis of Russian Democracy: The Dual State, Factionalism and the Medvedev Succession (2011), The Quality of Freedom: Khodorkovsky, Putin, and the Yukos Affair (2009) and Russian Politics and Society (4th edn., 2008). Professor Sakwa is a member of the Academy of Social Sciences.

Cambridge weather

Weather: No-one visits the UK without thinking about the weather, which is basically unpredictable, depending on whether it chooses to arrive from the north, south, east or west. However, the Cambridge area has the lowest average rainfall of anywhere in the British Isles. Throughout the month of April daytime temperatures will generally reach highs of around 13°C, that's about 55°F. At night the average minimum temperature drops down to around 7°C, that's 44°F. In recent times the highest recorded temperature in April has been 25°C that's 77°F, with the lowest recorded temperature -8°C, about 18°F.

It is expected to rain on 11 days in April.

The average daily relative humidity for April is around 71%.

The average daily wind speed in April has been around 17 kph, that's the equivalent to about 11 mph, or 9 knots. In recent years the maximum sustained wind speed has reached 54 kph, that's the equivalent of around 33 mph, or 29 knots.

It is very unlikely to snow in April, but it has been known to happen!




Map of Fitzwilliam College

In Architecture of Oblivion Andreas Schönle offers an ambitious and wide-ranging culturalhistorical account of the place of ruins in Russian culture, asking why they have never enjoyed the status that they enjoy in Western Europe, and examining how they have contributed to the development of historical consciousness in Russia from the eighteenth century to the present day. Schönle's compelling narrative moves from pre-romanticism and Karamzin's 'Poor Liza' through nineteenth-century and modernist literary and artistic treatments of ruins (classical and Russian), responses to the depopulation and dilapidation of Petrograd in the early 1920s, and representations of the fate of Leningrad in and after the blockade, before moving to a trenchant examination of Brodsky's imagery of ruins and the function of ruins in the projects of the 'paper architects'. Schönle ends by arguing that former Moscow mayor Luzhkov's views and implementation of modernisation chime with 'the Soviet authorities' notion that ruination can be subversive and that progress can be achieved only at the cost of disowning the past, or rather at the cost of substituting authentic historical relics with a packaged, glossed-over simulacrum'.

Schönle has written an erudite, methodologically sophisticated, but always accessible and engaging contribution to the cultural history of Russia, one that is eminently worthy of recognition by award of the Nove Prize for 2011.



- The prize, of one hundred and fifty pounds, is offered annually for a scholarly, peer-reviewed article of high quality in any of the disciplinary and geographical areas which fall within the BASEES remit. The term 'article' can be taken to include a chapter in an edited volume.
- 2. The author of the nominated article must be registered as a postgraduate at a higher education institution at the time the final version of the article is approved for publication, and after the editorial process is complete and all revisions have taken place. Written evidence of this must be provided in the form of a letter from the editor. Proof of postgraduate status must also be supplied.
- 3. Articles nominated for consideration must be of a scholarly character and constitute original research. They must be in English, and must have received final acceptance for publication within the 12 months of the calendar year preceding the annual closing date for nominations.
- 4. The article must be of no fewer than 5,000 words and no more than 15,000 words in length.
- Co-authored articles may be nominated, provided that they are accompanied by clarification of the input of the postgraduate student (this does not apply if all of the co-authors are postgraduate students).
- 6. The authors of the nominated article must at the time of nomination be members or associate members of the British Association for Slavonic and East European Studies. It is the responsibility of the nominator to check the BASEES membership status of potential nominees and ensure that membership is in place prior to nomination. Nominations of non-members will not be considered.
- 7. Awards will be made by a jury whose membership will be approved by the Executive Committee of the Association, and which will normally consist of two members of the committee.
- 8. The jury may divide the Prize equally between not more than two nominated articles in any year; or they may make no award in any year in which no article of sufficient merit presents itself.
- 9. Articles may be nominated by the authors, or by editors, librarians or other scholars.
- 10. The nominated article(s) should be supplied in electronic form and should include a cover sheet with full details of the author, including contact details, and of the article.
- 11. The deadline for submission of nominations shall be **15 September** each year in respect of articles whose date of final acceptance is the previous calendar year. The prize is awarded (if a recommendation is made to do so) at the Association's annual conference in the spring of the calendar year following the deadline for submission of nominations.
- 12. Nominations should be made on the standard form for this purpose, which is available as a download from this page, and submitted to the Secretary of the Association.




